- Your Caring Way.

The purpose of the evaluation is to assess how the programs are meeting carer support needs and if they are improving wellbeing and participation for carers.

#### Who is conducting the evaluation?

This project is being conducted over the period of April 2022 to June 2024.

### **How will my information be kept confidential?**

All information you provide will be kept confidential and used for this evaluation and future evaluations of the Carer Gateway. All data will be de-identified in any reporting. This means no names or other identifying information will be used. Your personal information is protected by the Privacy Act 1988.

All data collection will be undertaken in accordance with The Research Society Code of Practice, ISO 20252 Standards and the Market and Social Research Privacy Principles. The University of New South Wales, The Social Research Centre and Ipsos ATSIRU are fully compliant with the Australian Privacy Principles.

The information will be kept for a minimum of 7 years after the completion of the evaluation.

UNSW will also provide an electronic copy of survey data to the Department of Social Services where it will be stored in a password protected system. This copy will not contain any identifying information about you.
