



2024 Early Childhood Education and Care National Workforce Census Privacy Notice

Please ensure that this notice is made available to all persons employed at your service/s that are included in the National Workforce Census and a copy is posted in a prominent place for parents/guardians.

The Australian Department of Education (the Department) requires all approved child care providers to complete the 2024 Early Childhood Education and Care National Workforce Census (NWC). The Social Research Centre is conducting the NWC on behalf of the Department.

The NWC is a mandatory requirement for all approved child care providers under section 67FH of *A New Tax System (Family Assistance) (Administration) Act 1999* (Family Assistance Administration Act), and is one of the conditions for continued provider approval under the family assistance law. It is therefore important that the NWC is completed for each of your early childhood, education and care service/s.

Information collected as part of the NWC is protected information under the Family Assistance Administration Act. This means that the Department and the Social Research Centre may only use or disclose that information in accordance with that Act.

Information collected as part of the NWC

The 2024 NWC will collect certain information including:

- the type of service and operational matters relating to the service such as the service's preschool program delivery.
 - in aggregate form (totals numbers only), children attending the service and the characteristics of those children (such as Aboriginal and/or Torres Strait Islander status or long term additional needs). If you do not want your child included in the count, please advise your service by 15 April 2024.
 - information on persons employed by the service, including qualifications held and demographics (including Aboriginal and/or Torres Strait Islander status).

Please note; the NWC <u>does not</u> collect the names of any employees or children.

The NWC asks services to nominate a nickname or codename for each worker submitted as part of the NWC that will only ever be used by the Social Research Centre in the provision of follow up with services to ensure data quality. Once the data quality control period ends, the nickname or codename of workers is destroyed. The Department is not provided with this information.

Use and disclosure of NWC data

All data published is at the national, state and territory level only. You can see how NWC data is published by visiting the Department's NWC website at <u>https://www.education.gov.au/early-childhood/early-childhood-data-and-reports/national-workforce-census</u>

Information collected as part of the NWC may be used or disclosed by the Department:

- for early childhood education and care workforce analysis and related policy development;
- for programs administered by the Department that support the early childhood education and care sector;
- to support the delivery and administration of the Preschool Reform Agreement;
- to link with other information to improve programs, policies and outcomes for the early childhood education and care workforce and young children; and
- otherwise in accordance with the Family Assistance Administration Act.

Information collected as part of the NWC may also be disclosed to:

- other Australian Government departments, authorities and agencies with responsibility for early childhood education and care policy development;
- the Australian Bureau of Statistics (ABS) for the purposes of the ABS, including but not limited to statistical analysis of child care providers or services;
- State and Territory government departments, authorities and agencies with responsibility for early childhood education and care policy development or administration of the Education and Care Services National Law, for the purposes of that responsibility or administration;
- researchers with a genuine interest in the field of early childhood education and care, for the purposes of research of interest to the Department.

The Department and the Social Research Centre will not disclose personal information submitted as part of the NWC to any overseas recipients.

The Department may also use contact details provided voluntarily in Section E of the NWC "Recontact" for the purpose of recontacting that service in relation to participating in other research activities relating to the early childhood education and care sector being undertaken by the Department (or a contractor of the Department).
