Introduction

One of your parents or guardians said we can ask you to do a survey about your food consumption in the last seven days. By completing this survey, you will earn a \$10 incentive.

What is this study about?

This survey asks about what foods you have eaten in the last seven days. It should take you about 15-20 minutes. It may take some people longer. The Social Research Centre, a research company is running the survey for the Australian Government Department of Health, Disability and Ageing. All information is stored in Australia.

All your answers are private. You can stop anytime you want to or just say prefer not to say if you do not want to answer some of the questions.

You can take a break from the survey if you want to - just close your browser. When you want to come back to the survey, click on your survey link and you will go back to where you left the survey. You are also free to stop at any time with no requirement to complete the remainder of the questions.

You do not have to do the survey if you do not want to.

The survey will help the Department to understand what food Australians eat on a regular basis to help them investigate cases when people get sick from eating contaminated foods. The survey data will be used solely by OzFoodNet for foodborne disease outbreak investigations. OzFoodNet is Australia's enhanced foodborne disease surveillance system with epidemiologists located in each jurisdiction and the Department focused on investigating foodborne disease (https://www.health.gov.au/our-work/ozfoodnet-network).

What will the study involve for me?

If you decide to take part in the research study, we will ask you to complete an online questionnaire. The questions being asked include whether you have eaten poultry, eggs, salad/produce, vegetables, fruit, drinks, meats, seafood, milk/dairy, nuts, snack foods, sauces, and herbs/spices.

What happens in the survey?

It would be best if you tried to answer all the questions by yourself, but your parents can watch or help you if they want to.

Personal information is stored securely and The Social Research Centre de-identifies any personal information as soon as is reasonably practicable and as soon as that information is no longer relevant or required in identifiable format for the primary purpose of conducting the research according to the research brief provided by our clients.
