

## Participant Information Sheet

Project title: **GENERATION**

### What is the project about?

GENERATION is a national study that follows young Australians as they transition to life beyond school. This landmark study reflects the collective experience of young Australians and provides valuable insights into young people's career interests and post-school plans.

Results from the study help State and Federal Governments improve education across Australia.

GENERATION began in 2022 and is expected to run for ten years. This year, we are conducting the fourth wave of GENERATION, which will run from September 2025.

Students who have recently completed the Student Experience Survey (SES) have been invited to join the GENERATION Study and share your experiences.

You are only being asked to participate in one survey at this stage. You will be asked if you agree to be re-contacted and join our longitudinal sample. If you agree, separate invitations to participate in future surveys will be sent next year.

### Who is involved in the project?

GENERATION is being undertaken by researchers from the Australian National University (ANU), the Australian Council for Educational Research (ACER) and the Social Research Centre (SRC). POLIS: The Centre for Social Policy Research at the ANU is leading the research.

The research has been commissioned by the Australian Department of Education and all Australian state and territory departments of education.

### Who has been asked to participate?

Eligible young people who were in Year 10 at an Australian school in 2022 and provided valid contact information at the end of the SES have been invited to participate in Wave 4 GENERATION and will be invited to join the ongoing study.

### What does participation in the GENERATION mean for you?

You have been invited to complete an online survey, which will take about **30 minutes**. You will be asked about the activities you have participated in this year, including any study or training, if you have been working, or if you are on a gap year.

The survey also includes questions about the financial implications and impacts of any current or future study and training plans. We have included questions about your use and perceptions of Generative AI and how it has influenced your career planning.

There will also be questions about your background (including whether you have a disability or long-term medical condition), your mental health and wellbeing and your social supports. Information about your background will assist in the development of education policies that address your needs.

The survey is **voluntary**, and you can exit the survey at any time. You can withdraw your information from the project at any time prior to the end of fieldwork.

All reporting, including summary reports, will use de-identified data, meaning your individual responses will not be able to be identified.

You will be asked if you consent to be re-contacted and join the GENERATION sample. If you agree, you will receive an invitation to participate in future waves. Agreeing to be re-contacted will not impact your ability to participate in this wave, and your participation in any or all future waves of GENERATION is voluntary.

You will be asked to consent to link your data to your recently completed SES and your previous participation in NAPLAN and the Australian Early Development Census (a measurement of child development completed by your teacher in your first year of school).

Linkage will **make your information more useful**. The linkage will be undertaken by the Australian Institute of Family Studies, which has been reviewed and certified by the government as being able to perform data linkage work in a safe, secure and appropriate manner. Consent to linkage is voluntary and is not required to participate in the survey.

### **What are the benefits of taking part?**

You will receive a \$25 electronic gift card as a thank-you for your time. This will be sent to your nominated email address within the week of completion of the survey.

### **How will the research be used?**

Information collected in this survey will be used to help gain a better understanding of your goals, help the government understand how to support young people's career goals better, and improve post school pathways and support for future generations. Background information will enable researchers to understand whether experiences vary by personal circumstances.

Survey and linked information will be used in reports, publications and on the GENERATION website. Individual responses will not be identified in reports available to the general public.

### **How will my information be kept confidential?**

We will protect the confidentiality of your responses to the extent permitted by law. Due to the nature of this research and the need for data linkage, anonymity is not practicable. However, your name and contact details will be kept in a separate, password-protected computer file from any data that you give us. Any survey and linked information will not be looked at on their own but will be combined with those of other participants and analysed as a group.

Your personal information will not be disclosed to any other person or body unless you consent, or it is required by law, and will not be used for direct marketing or promotional purposes. Individuals who take part in the survey will not be identified in any report or publication.

In collecting your personal information within this research, the ANU, ACER and SRC must comply with the Privacy Act 1988. - Access or seek correction to their personal information;

### **Where will the data be stored?**

Data that contains personal information (such as names, date of birth, and address) will never be used or stored together with survey responses. Your contact information will be held by the SRC on behalf of ANU. The data collected in this survey will be de-identified (i.e. any identifying information will be removed) and stored separately by the SRC. De-identified data will then be securely archived in the Australian Data Archive for research purposes for at least five years following publication of the results. All data will be stored and processed within Australia, no information will be transferred or disclosed to overseas recipients.

### **Are there any risks from taking part?**

There are some potential risks for participating in this research. You only need to answer questions if you feel comfortable and safe to do so.
