



## 2026 Early Childhood Education and Care National Workforce Census Privacy Notice

Please ensure that this notice is made available to all persons employed at your service/s that are included in the National Workforce Census and a copy is posted in a prominent place for parents/guardians.

The Australian Government Department of Education (the department) requires all approved child care providers to complete the 2026 Early Childhood Education and Care National Workforce Census (the Census). The Social Research Centre (SRC) is conducting the Census on behalf of the department.

### Why we are collecting this information

The information collected through the National Workforce Census supports governments to understand the availability, characteristics and distribution of the early childhood education and care workforce. This information is used to inform workforce planning, program design, policy development and reporting at the Australian, state and territory levels.

It is important that the Census is completed for each of your ECEC service/s, this is required under section 67FH of *A New Tax System (Family Assistance) (Administration) Act 1999* (Family Assistance Administration Act).

Information collected as part of the Census is protected information under the Family Assistance Administration Act. This means that the department and the SRC may only use or disclose that information in accordance with that Act.

Before a service completes the Census, the department provides the SRC with service contact information so the SRC can contact services for the purpose of administering the Census.

### What information is collected

The 2026 Census **does not** collect the names of **workers or children**, however, it will collect certain information including:

- the type of service and operational matters relating to the service such as the service's preschool program delivery;
- head counts of children attending the service and the characteristics of those children (e.g. number of children who identify as being of Aboriginal and/or Torres Strait Islander origin or number of children with a long term health condition);
- head counts of workers and some characteristics of those workers such as the number of workers with less than 1 year of experience or number of workers identifying as an Aboriginal and/or Torres Strait Islander person; and
- limited business information about service providers, including sole traders, where this is necessary for early childhood education and care workforce analysis. In some cases, this information may be reasonably identifiable and is handled in accordance with applicable privacy obligations.

**If some parents do not want their child included in the head count then they may opt-out. The service should be advised of any opt-outs by 21 September 2026. By not opting out, the service will collect and provide this information and will handle the information as outlined in this privacy statement.**

The Census also collects limited personal information about the person completing the Census or the service's nominated contact person, such as their name, work email address, work phone number and position title. The SRC uses this information to administer the Census, respond to enquiries, help services complete the Census, and contact services if follow-up is needed for data quality or clarification.

### **How the information will be used**

The department publishes the Census data on its website, which you can visit at [www.education.gov.au/early-childhood/early-childhood-data-and-reports/national-workforce-census](http://www.education.gov.au/early-childhood/early-childhood-data-and-reports/national-workforce-census)

Information collected as part of the Census may be used by the department:

- for early childhood education and care workforce analysis and related policy development;
- for programs administered by the department that support the early childhood education and care sector;
- to support the delivery and administration of the Preschool Reform Agreement;
- to link with other information to improve programs, policies and outcomes for the early childhood education and care workforce and young children; and
- otherwise in accordance with the Family Assistance Administration Act.

Information collected as part of the Census may also be disclosed to:

- other Australian Government departments, The Productivity Commission, authorities and agencies (such as Australian Education Research Organisation (AERO) and 'SNAICC - National Voice for our Children') with responsibility for early childhood education and care policy development;
- the Australian Bureau of Statistics (ABS) for the purposes of the ABS, including but not limited to statistical analysis of child care providers or services;
- state and territory government departments, authorities and agencies with responsibility for early childhood education and care policy development or administration of the Education and Care Services National Law; and
- researchers with a genuine interest in the field of early childhood education and care and for research for the public benefit.

Census data handled by SRC are stored on servers located in Australia as described in [srcentre.com.au/privacy](http://srcentre.com.au/privacy). The department will not disclose personal information submitted as part of the Census to any overseas recipients.
